The requirement of Bank Statements was neither explicitly stated as a "knock-out" criterion nor was it highlighted as mandatory in the applicable set of documents we followed. Please note that we provided audited balance sheets for 3 years and income tax returns for 3 years in the bid, which are legally recognized proofs of financial standing. In the presence of these documents, the absence of a Bank Statement should not warrant disqualification. Moreover, even if Bank Statements were required under the second set of criteria, they carried nominal marks (not a disqualifying condition – copy attached). The appropriate action would have been to deduct marks for the missing document rather than rejecting the entire bid. Such a stringent interpretation discourages competitive participation and undermines the principles of fairness in public procurement.
